Since the December 2022 Board meeting, four decisions have been circulated electronically for approval by no-objection consent in line with Section 11 of the Board and Board Committee Operating Procedures.

1) On 10 February 2023, Board Members were invited to consider **approval of the appointment of Board and Committee Members.** 

No objections were received prior to the end of 22 February 2023 and the following decision was therefore entered into the record:

In accordance with Section 11.3 of the Board and Board Committee Operating Procedures, on a no-objection basis, the Gavi Alliance Board:
