6. Programme Duration²: HSS: 2021-2025 ; TCA: 2022 - 2025

7. Annual Amounts: (subject to the terms of the Partnership Framework Agreement)

This is the total amount approved by Gavi for the entire duration of the programme, estimated to be disbursed under the Programme. Annual amounts are defined as per section 4.1 of the PFA. Any requested adjustments to the Annual Amounts will be subject to Gavi approval. It is essential that Country's Health Sector Coordination Committee (or its equivalent) be involved with this process both in its technical process function and its support during implementation and monitoring of the Programme. Further, amounts beyond the current Gavi strategic period (2021 – 2025) where applicable are indicative and are subject to the availability of funds and relevant approvals by the Gavi Board.

The Country acknowledges that: (a) a proportion of or the full Annual Amount may be disbursed directly to an agreed implementing partner, such as WHO, UNICEF and/or expanded partners, if agreed between Gavi and the country rather than to the Country; (b) each Annual Amount may be disbursed in a number of tranches at quarterly or six-monthly intervals; and (c) such disbursement shall constitute the satisfaction of the payment of that amount as if it were made to the Country.

Provision of technical assistance will continue to be channeled through partners (including UN partners, global and local partners, academic institutions and CSOs).

Utilisation of Gavi support is subject to performance monitoring. If the bank account information most recently provided to Gavi has changed or changes prior to disbursement, the Country shall complete a bank account information form updating the relevant information.
