1. Composition and Functioning of Inter-agency Coordinating Committee (ICC) / Health Sector Coordinating Committee (HSCC)

Coordination of GAVI supported programmes in Bangladesh is the mandate of the Local Consultative Group (LCG), which is the highest level committee. It has a diverse representation profile: ministries, development partners and civil society organizations.

Minutes of May 2012 ICC/HSCC meeting where committee members have discussed and approved both the APR 2011 and the proposed 2012 workplan/budget were provided. Minutes of the LCG meeting in June 2012 were also provided with many agenda items discussed and approved at a highest level of the health sector.

For the HSS section re-submission, updated signatures dated February 2013 have been provided showing involvement of HSCC members and ICC members, including bilateral and multilateral partners (USAID, The World Bank, DFID, WHO, UNICE, JICA) and local NGOs (Rotary International, BRAC).

2. HSS workplan and budget (financial management and reporting)

The APR provides information on HSS activities in 2011, and detailed plans/activities for 2012 and 2013.

Country reported receipt of US\$ 7.24 million in 2009, however activities delayed until 2011. An expenditure of US\$ 1.75 million is reported in 2011 (24% of the total) and US\$ 3.3 million (45%) in 2012. A balance of US\$ 2.1 million is reported for 2013, that is to be expended, and thus a request for US\$ 6.42 million for 2013 is made. Budget absorption rate was very low at the beginning of the reprogramming period. However, US\$ 7 million will be spent overall by the next APR process, which justifies the request of US\$ 6.42 million for 2013 made by the country.

The reprogrammed work plans and budgets presented in 2011 APR for fiscal years 2011, 2012 and 2013 include other 11 new activities.

For 2013, activities planned show a total revised budget of US\$ 8.6m (reflecting the US\$ 6.4 from the last tranche and the balance of US\$ 2.1 million from previous year). Increased expenditure is due to proposed expansion of activities in additional 19 low performing districts (from existing 13).

3. Implementation of the Health Systems Strengthening (HSS) proposal

Bangladesh HSS window was approved in 2008 pending conclusion of FMA. While the first tranche of grant was disbursed in 2009, implementation of activities was delayed until 2011, at which point the country requested for approval of HSS reprogramming.

The goal of Health System Strengthening in Bangladesh is to provide universal MCH services delivery through strengthened human resources management, improved logistics management, and increased community participation and demand, which will contribute to achieving MDGs 4 and 5 goals.

Key indicators monitored during the HSS proposal implementation process are:

- 90% of HA and FWA vacant posts are filled
- 90% of supervisory & performance reports available
- Critical gaps in equipment & physical structures addressed
- High quality and appropriate MNCH services available

The original HSS proposal targets 13 districts (expanded to 19 as part of the reprogramming and request for 2013) of the country and has 4 key objectives focussing on (i) health workforce (Health Assistants and Family Welfare Assistants), (ii) logistics and supervision capacities, (iii) equipments and physical infrastructure and (iv) high quality MCH services.

4. Summary of the HSS Review

Bangladesh HSS proposal has taken a lot time to kick off due to FMA issues and in-country bottlenecks regarding recruitment and procurement processes.

This is an excellent report with sufficient details for 2011, 2012 and 2013, and makes it easy for IRC to review and understand the HSS activities and plans, with clear tables and linkages between budgets and activities.

The results reported on the 2011 APR show that the HSS program is catching up and on track. Funds utilisation has significantly improved in the last two years.

The IRC commends the country for an excellent report, showing progress made against targets, clear expenditure analysis and proposed activities for 2013. The IRC further recommends that the country should modify Table 9.1.3a to depict changes in activity implementation timeframe per year (from 2007-2012 to 2011 onward) by the next APR.

5. IRC Review Recommendations

Recommendation: Approval of second and final tranche of the Bangladesh HSS proposal (US\$ 6.428 million)

6. TAP recommendations

Recommendation: Submission of an audit report conducted by external audit firm based on ToR provided by GAVI for the financial year that ended June 30, 2012.

GAVI Alliance Terms and Conditions

Countries will be expected to sign and agree to the following GAVI Alliance terms and conditions in the application forms, which may also be included in a grant agreement to be agreed upon between GAVI and the country:

FUNDING USED SOLELY FOR APPROVED PROGRAMMES

The applicant country ("Country") confirms that ail funding provided by the GAVI Alliance for this application will be used and applied for the sole purpose of fulfilling the programme(s) described in this application. Any significant change from the approved programme(s) must be reviewed and approved in advance by the GAVI Alliance. All funding decisions for this application are made at the discretion of the GAVI Alliance Board and are subject to IRC processes and the availability of funds.

AMENDMENT TO THIS PROPOSAL

The Country will notify the GAVI Alliance in its Annual Progress Report if it wishes to propose any change to the programme(s) description in this application. The GAVI Alliance will document any change approved by the GAVI Alliance, and this application will be amended.

RETURN OF FUNDS

The Country agrees to reimburse to the GAVI Alliance, all funding amounts that are not used for the programme(s) described in this application. The country's reimbursement must be in US dollars and be provided, unless otherwise decided by the GAVI Alliance, within sixty (60) days after the Country receives the GAVI Alliance's request for a reimbursement and be paid to the account or accounts as directed by the GAVI Alliance.

SUSPENSION/ TERMINATION

The GAVI Alliance may suspend all or part of its funding to the Country if it has reason to suspect that funds have been used for purpose other than for the programmes described in this application, or any GAVI Alliance-approved amendment to this application. The GAVI Alliance retains the right to terminate its support to the Country for the programmes described in this application if a misuse of GAVI Alliance funds is confirmed.

ANTICORRUPTION

The Country confirms that funds provided by the GAVI Alliance shall not be offered by the Country to any third person, nor will the Country seek in connection with this application any gift, payment or benefit directly or indirectly that could be construed as an illegal or corrupt practice.

AUDITS AND RECORDS

The Country will conduct annual financial audits, and share these with the GAVI Alliance, as requested. The GAVI Alliance reserves the right, on its own or through an agent, to perform audits or other financial management assessment to ensure the accountability of funds disbursed to the Country.

The Country will maintain accurate accounting records documenting how GAVI Alliance funds are used. The Country will maintain its accounting records in accordance with its government-approved accounting standards for at least three years after the date of last disbursement of GAVI Alliance funds. If there is any claims of misuse of funds, Country will maintain such records until the audit findings are final. The Country agrees not to assert any documentary privilege against the GAVI Alliance in connection with any audit.

CONFIRMATION OF LEGAL VALIDITY

The Country and the signatories for the government confirm that this application is accurate and correct and forms a legally binding obligation on the Country, under the Country's law, to perform the programmes described in this application.

CONFIRMATION OF COMPLIANCE WITH THE GAVI ALLIANCE TRANSPARANCY AND ACCOUNTABILITY POLICY

The Country confirms that it is familiar with the GAVI Alliance Transparency and Accountability Policy (TAP) and will comply with its requirements.

ARBITRATION

Any dispute between the Country and the GAVI Alliance arising out of or relating to this application that is not settled amicably within a reasonable period of time, will be submitted to arbitration at the request of either the GAVI Alliance or the Country. The arbitration will be conducted in accordance with the then-current UNCITRAL Arbitration Rules. The parties agree to be bound by the arbitration award, as the final adjudication of any such dispute. The place of arbitration will be Geneva, Switzerland. The language of the arbitration will be English.

For any dispute for which the amount at issue is US\$ 100,000 or less, there will be one arbitrator appointed by the GAVI Alliance. For any dispute for which the amount at issue is greater than US \$100,000 there will be three arbitrators appointed as follows: The GAVI Alliance and the Country will each appoint one arbitrator, and the two arbitrators so appointed will jointly appoint a third arbitrator who shall be the chairperson.

The GAVI Alliance will not be liable to the country for any claim or loss relating to the programmes described in this application, including without limitation, any financial loss, reliance claims, any harm to property, or personal injury or death. Country is solely responsible for all aspects of managing and implementing the programmes described in this application.

USE OF COMMERCIAL BANK ACCOUNTS

The eligible country government is responsible for undertaking the necessary due diligence on all commercial banks used to manage GAVI cash-based support, including HSS, ISS, CSO and vaccine introduction grants. The undersigned representative of the government confirms that the government will take all responsibility for replenishing GAVI cash support lost due to bank insolvency, fraud or any other unforeseen event.
