This Decision Letter sets out the Programme Terms of a Programme.

5. Programme Title: Health Systems Strengthening (HSS)

6. HSS terms:

This Decision Letter closes the existing HSS Programme. Any amounts of HSS support remaining will be reprogrammed to the Country's Ebola EPI Recovery Plan.

The amount for 2008 has been reduced by US\$ 523,303. The amount for 2011 has been reduced by US\$ 530,750. The total of these two amounts (US\$ 1,054,053) is reprogrammed to the Country's Ebola EPI Recovery Plan.
