Update on Pakistan's allocation of doses for pneumococcal vaccines in 2012

We are writing in relation to Pakistan's introduction of **pneumococcal vaccines** with support from the GAVI Alliance. In a letter dated 8 September 2010, we informed you that your application for pneumococcal vaccines had been approved by the GAVI Executive Committee. In a letter dated 20 October 2011, we provided you with information on the allocated number of doses and corresponding co-financing requirements for 2012.

In light of the recent PCV10 introduction in Pakistan in October 2012, we are writing to provide you with updated information on the number of doses, related injection safety material and co-financing requirements for 2012.
