18. Other conditions:

Country has presented an official request to Gavi to switch from measles vaccine to measles- rubella vaccine for the routine measles second dose with country funding for the equivalent cost of the rubella component. As such, country will make the required payments to UNICEF SD as indicated in the table below.

^{*} Refer to Decision Letter (15 December 2014), MR vaccines for second dose schedule to be procured by Gavi in 2014 (593,705) and 2015 (1,099,405)-i.e, a total of 1,693,110 doses- were not procured as Tanzania had a total of 1,782,730 doses of MR doses leftover after the Gavi-funded campaign in 2014. The 1,6,93,110 doses were therefore nullified. However Tanzania should still procure the doses allocated to it for 2014 (615,695) and 2015 (1,026,112) for use in 2016 in addition to the doses indicated for 2016.

In the case of procurement through UNICEF, Gavi-funded vaccines will be purchased only after receipt of full payment of the respective amounts due from Country for the number of doses as indicated in this Decision Letter. Country is required to submit a request for a Cost Estimate to UNICEF, with a clear reference to the approval code and approval year. Country will inform Gavi

^{**}Tanzania procured 800,000 doses of MR in 2015/15 outside of the Gavi procurement process. First instalment 500,000 doses of MR vaccine CE 10015024 (order number 45137473 delivered in December 2014), and a second instalment of 300,000 doses of MR CE 10015991 (order no 45140348 delivered in June 2015). Using the assumption of 57% coverage of MR2 in 2015, we assume that 292,308 doses of these 800,000 were for MR2. Therefore, 292,308 doses of these 1,026,112 have already been distributed to Tanzania so only a balance of 733,804 remains to be shipped (relates to 2015 allocations only).



Secretariat when payment of the respective amount due under this Cost Estimate has been fully made to UNICEF.

In the event that country wishes to revert to measles vaccine, country should inform UNICEF and Gavi immediately in order to agree on an appropriate arrangement.
