PARTNERSHIP FRAMEWORK AGREEMENT  
FOR  
VACCINE AND/OR CASH SUPPORT

THIS PARTNERSHIP FRAMEWORK AGREEMENT (this “Agreement”) is dated as of (the “Effective Date”) between:

- (1) THE GOVERNMENT OF INDONESIA (the “Country”), as represented by the Ministry of Health (the “Government”),
  - (2) THE GAVI ALLIANCE, an independent non-profit foundation within the meaning of Articles 80 to 89 of the Swiss Civil Code with a registered address at 2 Chemin des Mines, Geneva, 1202 (“GAVI”); and
- (each, a “Party” and, together, the “Parties”).

### **17.9. Counterparts**

This Agreement may be executed in one or more counterparts, which shall have the same effect as if the signatures on the counterparts were on a single copy of this Agreement.

### **17.10. Exclusion of Third Party Rights**

Unless expressly stated to the contrary, no part of this Agreement shall create any rights in favour of any third party that is not a Party to this Agreement which shall impose any obligation on, or be enforceable against GAVI.

- (2) GAVI ALLIANCE, sebuah yayasan nirlaba independen menurut Pasal 80 sampai 89 Undang-undang Hukum Perdata Swiss dengan alamat terdaftar di 2 Chemin des Mines, Geneve, 1202 ("GAVI"),

(Masing-masing, disebut "Pihak" dan, secara bersama-sama, disebut "PARA PIHAK").

### **17.10 Pengecualian Hak Pihak Ketiga**
