

SUBJECT: EVALUATION ADVISORY COMMITTEE CHAIR REPORT

Section A: Introduction

• This report provides the Board with an overview of the activities of the Evaluation Advisory Committee (EAC) since the Board last met in June 2017.

- The EAC met in Geneva on the 24-25 October 2017 where the members:
 - a. Were updated on ongoing Gavi evaluation activities including those related to strengthening the Gavi Evaluation function;
 - Discussed the quality and usefulness of the baseline assessment report for the Evaluation of Targeted Country Assistance (TCA) provided through the Partners' Engagement Framework (PEF);
 - (i) The PEF TCA evaluation was highlighted as an example of how Gavi is learning and in real-time making changes. The baseline findings were discussed at an Alliance workshop which identified priority areas for action. Areas for improvement include capacity building approaches for TCA and skill transfer and improving TCA accountability measurement. These lessons learned are informing the 2018 TCA planning and improvements on delivery.
 - c. Discussed the quality and usefulness of the assessment of the Full Country Evaluations first phase reports and were updated on the Full Country Evaluations second phase:
 - (i) The FCE second phase was presented as an example of how Gavi is strengthening collaboration with other institutions, in this case The Global Fund. Identified areas of collaboration: sharing best practices and considering joint efforts for planning, monitoring, implementing the evaluation and in-country evaluation capacity strengthening activities, specifically in two countries (Mozambique and Uganda) were both projects are ongoing simultaneously.
 - d. Discussed the potential approach for Health System and Immunisation Strengthening evaluation based on the evidence needs;
 - e. Discussed the results of the Peer review of Gavi's evaluation function presented by Nick York, which aims to inform the review of the Gavi Evaluation Policy, the review of the EAC Charter and improve the evaluation function within Gavi;



- (i) The report provided several strategic recommendations, such as: 1) To identify and articulate the purpose of the Gavi Evaluation function and audience for its evaluations (including reference to the Board); 2) To develop a more utilisation-focused approach to evaluation; 3) To review and clarify the EAC role; 4) To re-examine provisions for independence (structural/behavioural/organisational independence) and 5) To develop an approach for country evaluation capacity strengthening.
- f. Discussed and provided guidance on the preliminary evaluation workplan 2018-2020 considering the increasing demand for evaluations; and
- g. Were updated on the first set of revisions of the EAC Charter.
- The EAC and PPC had a first joint meeting on 25 October 2017 where the main objective was to identify key areas of collaboration between the two committees, aiming for better harmonisation and coordination between the PPC and the EAC, a more systematic identification of areas that may benefit for a prospective evaluation, a better anchoring of evaluation design as part of Policy and Programme design, and a more effective use of evaluation findings for Policy and/or Programme design and implementation. It was agreed that a joint session of the EAC and PPC would be organised annually.
- The next EAC meeting will take place in Geneva in April 2018, and will include a status update on the follow-up of the recommendations of the peer review of the Gavi evaluation function, and any other relevant evaluation project updates will be part of the agenda.
- The evaluation findings are expected to continue informing the review of Gavi policies and programmes and the implementation of them, as well as, other upcoming evidence needs such as the Gavi Mid-term Review and the design of the Gavi 5.0 Strategy.
