

## ALLOCATION ROUND 6: Sinopharm & Sinovac Vaccines

4 August 2021

### Introduction

Based on current knowledge of COVID-19 vaccine supply availability, this sixth round of COVAX Facility allocations provides information on the provision of 100,000,000 doses of the Sinopharm and Sinovac vaccines, allocated to 60 participants as well as for the [COVAX Humanitarian Buffer](#), covering the period July – September 2021.

Of the total, 50,000,000 doses of the Sinopharm vaccine and 50,000,000 doses of the Sinovac vaccine were available to be allocated for this period. This allocation consists of 85,299,600 doses to 60 participants and 14,700,400 doses to the COVAX Humanitarian Buffer<sup>1</sup> for the period July to September 2021.

These doses are made available to the COVAX Facility through the [advance purchase agreements \(APAs\)](#) between Gavi and Sinovac, and Gavi and Sinopharm.

Facility participants not included in this round (and therefore not listed in the table below) either: elected to skip this particular allocation round, opted out of receiving the Sinopharm and Sinovac vaccines, have allocations subject to further clarifications, or had already reached higher levels of total population coverage than other participants through previous allocations (including donations).

### Overview of the Process

This sixth round of allocations took place as per the [Fair allocation mechanism for COVID-19 vaccines through the COVAX Facility](#), which was developed by WHO in consultation with its Member States. This allocation framework for fair and equitable access to COVID-19 health products sets forth the criteria and approach to allocation of vaccines through the COVAX Facility.

The operationalization of the Framework, in accordance with the principles and provisions set forth in the document, is performed by the Joint Allocation Taskforce (JAT), composed of staff from Gavi, the Vaccine Alliance and WHO, and the [Independent Allocation of Vaccines Group \(IAVG\)](#). The main purpose of the IAVG is to make validation assessments of proposals for Vaccine Allocation Decisions (“VAD proposals”), which outline the volumes of vaccines that should be allocated to each country/economy participating under COVAX within a given time frame. The IAVG will consider VAD proposals prepared and submitted by the JAT.

A vaccine allocation decision (VAD) proposal was developed by the JAT and shared with the IAVG for their review. For this round of allocation, doses allocated through previous rounds

of allocation as well as dose donations and reallocations were taken into account. Subsequently, the IAVG decision meeting for the round was held on 23 July 2021. The deliberations resulted in consensus on the VAD proposal, with no divergent views recorded.

The allocation was then validated by the WHO Deputy Director-General, and the decision was communicated to the Office of the COVAX Facility, administered by Gavi.
