Afghanistan Request for Additional Flexibility Funding of Health System Strengthening Programme

Honorable Minister,

I refer to the request for support for the additional flexibility funding to Afghanistan Health System Strengthening (HSS) Programme submitted to the Gavi Secretariat in March 2019.

In April 2019, the Independent Review Committee (IRC) reviewed your request and recommended approval with clarifications. Based on the clarifications presented, the IRC recommends **approval** of the HSS additional flexibility funding, as described in Annex A to this letter.

The programme budget endorsed by Gavi is for the years 2019 to 2021 with approved allocation for disbursement covering the years 2019 and 2020. Approval for 2021 disbursement will be requested from the Gavi High-Level Review Panel in 2020.

The attached Annex includes programmatic and financial information related to this additional flexibility funding to Afghanistan HSS.
