The Country is required to submit an updated Accountability Framework every six months. On an annual basis, the updated Accountability Framework must be accompanied by a narrative report and the Country will participate in a review meeting with Gavi and relevant partners.

The continued disbursement of funds is subject to: (i) the Country's satisfactory completion of the above reporting requirements and (ii) the remaining cash balance in the Country.
